

Workshop 3: The Art of the Difficult Deal - Contract Legalese

Sponsored research agreements contain many "standard" terms. Often, sponsored projects offices have limited access to attorneys to help understand and interpret them. As a result, sponsored projects negotiators are often forced to apply mechanistic rules which may create obstacles and bumps in negotiations. Using a combination of lecture, examples and interactive exercises, this workshop will teach the meaning and context of common legal clauses (such as conflict of laws, indemnification, disclaimer of liability and integration clauses), as well as how to use them to your advantage. Attention will also be spent on techniques to review difficult contracts and spot troublesome clauses or contract drafting. The workshop will then present how to analyze the risk and importance of particular terms for specific research projects and how to build and communicate positions persuasively and effectively during difficult negotiations. The course will draw from materials in negotiation, risk assessment and contract law to examine the contract review, negotiation and strategy. **Presenter:** Sherylle Mills Englander, Director, Office of Technology & Industry Alliances, University of California, Santa Barbara

9:15AM-10:15AM Pavilion Ballroom	<p>Keynote: The Ocean Observing Initiative - Extending Our Eyes Into the Sea</p> <p>Speaker: Dr. Robert Collier, Professor, Chemical Oceanography, Oregon State University</p> <p>Building on the heritage of the ship-based expeditionary era of the last century, oceanography is commencing a new phase in which scientists, managers, and the public seek continuous interaction with the ocean environment to better observe the earth-ocean-atmosphere system. Such approaches are crucial to resolving the full range of natural and human-driven changes in ocean processes that directly impact human society, our climate and the incredible range of natural phenomena found in the largest ecosystem of the planet. The Ocean Observatories Initiative (OOI) is a \$331M project enabled by the National Science Foundation's Major Research Equipment and Facilities Construction (MREFC) account. It will help create a new research and education platform that will accelerate understanding of the ocean and seafloor and their roles in the planetary environment. The distributed OOI Network will deploy sensors to study the coastal, regional, and global-scale ocean using permanent observatory installations and autonomous vehicles in continuous connection through the internet. The project will begin with a five-year construction phase and is designed for a subsequent 25-year operational lifetime. This project will transform the way we interact with the Oceans. NSF is also transforming the way they handle Large Facilities through the MREFC account. These new models introduce scientists to unfamiliar management territory and make life "interesting" for University Research Administrators!</p>



When an invention develops from the research, it is the technology transfer office's turn, with enthusiastic researchers envisioning changing the world with their innovation. What is not often discussed at the early stages of this process is the effect the IP terms in research agreements can have on the subsequent transfer of technology. This session will focus on the intersection between the sponsored projects and technology transfer offices. The mission of university technology transfer will be presented with a brief discussion of the common pressure points for technology transfer offices. The session will then move to an exploration of how common IP terms can either enhance or complicate the licensing process, presenting methods and alternative terms to consider to minimize any negative future impacts of difficult IP terms. Finally, the session will discuss how the technology transfer office can be engaged to support the sponsored projects office. 


