	How many research administrators does it take to set up a new grant account, and why
University Financial	does it take so long? Are you concerned about the length of time it takes to get a new account set up once the contract or notice of award has been received? We provide a case study of two attempts made by the Burns & Allen Research Institute over the course of three years to address the operational and customer service challenges faced by a recently
Overview	combined pre-and post-award office, using a new accounting system. The first case, an ad- hoc business improvement process, was only moderately successful but provided essential background data and valuable tools for a second, professionally facilitated process called value stream analysis. Over the course of three years, we reduced the time taken to fully process new grants/contracts from 40 calendar days to less than 2 weeks, and time to enter new projects into the accounting system from "unknown" to 3 business days or less. In this presentation we will cover basic data gathering/success rate tracking, re-assigning tasks & job descriptions, creating business process documentation, and our experience with applying a formal value stream analysis model to our organization. Participants will receive an overview of basic process improvement methods, and samples of tools and data tracking models used successfully by our research institute.
